



Nominations Deadline Extended until March 26th for ABIH Impact Award and Lynn C. O'Donnell Lifetime Achievement Award.

The deadline for submitting ABIH Impact and Lifetime Achievement Awards has been extended. Submissions must be received by ABIH on or before March 26, 2019, to qualify for the 2019 awards. Nominations received after March 26th will be automatically included for consideration in 2020.

Nominees for an ABIH Award must be an ABIH diplomate (Certified Associate Industrial Hygienist[®] or Certified Industrial Hygienist[®]) in good standing or a former diplomate who voluntarily surrendered the credential while in good standing.
