	C.	l have a minimum of 4 years of work experience in either: 1) Environmental Compliance, 2) Health and Safety, or 3) Management Systems.
	D.	Over the last 3 years, I conducted at least 20 audits totaling 100 days or more in either: 1) Environmental Compliance, 2) Health and Safety, or 3) Management Systems. Of the 100 days, a minimum of 20 days may be conducted on-site or virtually.

- 1. Review the CPEA Candidate Handbook pages for information on eligibility, the application process, and exam requirements. Complete the eligibility checklist for your own benefit.
- 2. Complete the online CPEA Application: profile information and education. Select one of the specialty paths: Environmental Compliance, Health and Safety, or Management Systems.
- 3. Pay the non-refundable Application Fee to gain access to the next stage.
- 4. Request official transcripts and/or an official Evaluation Report.
- 5. Request Character Reference Forms (CRFs) be completed on your behalf.
- 6. Complete the Audit Experience Form, send to supervisor/s to sign off. The supervisor must submit this form.
- 7. Complete the Work Experience Form.
- 8. Complete the Formal Training Form with supporting documentation.
- 9. Upload the completed *Work Experience Form* and *Formal Training Form* with supporting documentation to your assigned SharePoint folder. Check the SharePoint folder for updates, progress, and incomplete documentation.
